

ORDINANCE NUMBER 275

THE BOARD OF TRUSTEES OF THE TOWN OF HUGO, LINCOLN COUNTY, COLORADO, DOES HEREBY ORDAIN AND RESOLVE TO CHANGE THAT PORTION OF WEST SEVENTH STREET WEST COMMENCING AT THE INTERSECTION AT FIRST AVENUE AND SEVENTH STREET, CONTINUING AROUND THE CIRCLE AND ENDING WEST OF THE INTERSECTION OF FIRST AVENUE AND SIXTH STREET TO "PIRATE LANE" AND CHANGING THE ADDRESS NUMBER OF THE GENOA-HUGO SCHOOL FROM 220 TO 25.

Whereas, the Town of Hugo, hereinafter referred to as the "Town", in the County of Lincoln and the State of Colorado, is the body corporate operating as a statutory town pursuant to the general statutes of the State of Colorado and

Whereas, Colorado Revised Statutes 31-15-702(1)(a)(VIII) gives the governing body of each municipality the power and authority to name, or change the name, of any street or other public place with the municipality; and

Whereas, the Board of Trustees of the Town, hereinafter referred to as the "Board", has determined that it is in the best interests of the residents of the Town of Hugo, Lincoln County, Colorado, to change the name of the street referred to herein for both location and safety reasons, including resolving any conflicting addresses and to recognize the Genoa-Hugo School through naming the subject portion of the street after the school mascot;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF HUGO, COLORADO:

SECTION I. – CHANGE OF STREET NAME.

1. That portion of West Seventh Street West commencing at the intersection at First Avenue and Seventh Street, continuing around the circle and ending west of the intersection of First Avenue and Sixth Street shall be re-named as **Pirate Lane**.

2. As of the date of the adoption of this Ordinance, the street address of the Genoa-Hugo School shall be changed from 220 West Seventh Street, Hugo, Colorado, to 25 Pirate Lane, Hugo, Colorado.

3. This Ordinance and / or the information herein shall be conveyed to all municipal and Lincoln County departments, or organizations, which may be affected by the change of address, including all law enforcement, and fire and medical emergency entities, which cover or may cover the subject address. Further, the Town Clerk is authorized to take such action as the Lincoln County Clerk and Recorder may require reflecting the change of the street name in the Lincoln County records. The Town herein authorizes new street signs to be made and installed at the appropriate places as determined by the Board and the Hugo Town Marshal.

SECTION II. - VALIDITY.

If any part or parts of this Ordinance are for any reason held to be invalid such decision shall not affect the validity of the remaining portions of this Ordinance. The board hereby declares that it would have passed this Ordinance and each part or parts thereof, irrespective of the fact that any part or parts be declared invalid.

SECTION III. - REPEAL.

Existing or parts of any previous ordinance covering the same matter as embraced in this Ordinance are hereby repealed and all ordinances or parts of ordinances inconsistent with the

provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.

SECTION IV. - EFFECTIVE PERIOD.

The Town Clerk shall publish this Ordinance immediately after passage by the Board. The Ordinance shall take effect thirty (30) days after publication. The Town Clerk shall, thereafter, place the Ordinance in the Book of Ordinances.
