Minimum Fines/Fees for Code Enforcement – It is suggested that for a minimum fee schedule we start at a base number and increase by doubling, such as \$100 first offense, \$200 2nd offense, \$400 3rd offense – In December you said you would like to see this, are these the numbers you want?

Code Enforcement Miscommunication – Several residents feel that the communication regarding code enforcement is not the best.

What can we do to improve this?

Can we notify tenants as well as property owners?

What can we do to improve the perception of fairness and consistency of violations throughout town?

Firearms in Sensitive Spaces – Senate Bill 24-131 took effect on July 1, 2024, and prohibits carrying a firearm in Town Hall other than police officers. Previously, the Court Clerk would conceal carry. The Chief Marshal would like to have an ordinance for the court clerk to be able to conceal carry again.

The Marshals Office would like to move their office to the Historic Courthouse side of the Depot.

Handbook/Policy/Procedures – We need to review suggestions from the previous meeting (jury duty, nepotism policy, workday hours, breaks, paid lunches) and provide direction for updates.

Hugo Housing Authority Resolution and Agreement – Review the draft Reimbursement Agreement and corresponding resolution

Annual Designating of the Official Public Notice Location & Newspaper – Every year we are required to designate a public notice location and which newspaper we will be using. We will use our website as well as the front glass of Town Hall for agenda posting. This covers an online and physical presence as well as covers us in the event of an emergency.
